- Lashes are included in all makeup applications.
- Additional charge if we need to wash & dry before service (+\$40)
- Prices may vary based on complexity of the style.

Add-On Or Stand Alone Services:

- *Partial Face Makeup Application*
(Option of eye or foundation look)
- *Temporary Individual Lashes* - \$20
- *Clip-on Extension Application* - \$20
- Grooming the Groom- \$65 (Includes beard maintenance, hair style & skin perfecting airbrush makeup)

For the day of your services, please arrive with a clean face. Hair must be clean, completely dry and well brushed. There will be a \$20 charge for appointments that arrive with wet or damp hair.

TERMS & CONDITIONS

This document outlines the terms and conditions between Salon Fifty Four and client (bride). By entering into this Agreement, both parties agree to abide by the following terms.

1. SERVICES

- 1/1 SALON FIFTY FOUR agrees to provide services as agreed upon with the client.
- 1/2 The scope of services, including any additional fees for special requests, will be outlined and agreed upon in writing prior to the event.
- 1/3 We reserve dates at a first come, first serve basis.
- 1/4 Any service add-ons to contract will be based on availability.
- 1/5 \$100 fee per stylist applies for weddings scheduled on holidays, holiday weekends or before 8am.

2. PAYMENT

- 2/1 A non-refundable deposit of \$200 is required to secure the bridal services for the specified date. You may apply this payment towards day of services.
- 2/2 The standard convenience travel charge for on-site services is \$200 within the Green Bay city limits, no more than 30 miles.
- 2/3 Payments can be made via cash, check or card.
- 2/4 A 4% experience fee is added to all services.
- 2/5 A 20% gratuity will added to all services.
- 2/6 We require final payment to be completed no later than 30 days before your wedding to secure all arrangements. A final invoice will be sent to complete payment.

3. TRIAL RUN

3/1 A trial appointment may be scheduled in advance to discuss and finalize the look.

3/2 The trial appointment fee is separate from the overall service fee and must be paid on the day of the trial.

3/3 Your trial appointment is for one desired look. If you're considering more than one look and/or unsure, please reserve extra time so we can accommodate you fully.

3/4 If you choose to have a trial before securing our salon, we do not guarantee the original stylist or date.

3/5 You may book your trial appointment by calling our salon at 920.432.0601

4. CANCELLATION AND RESCHEDULING

4/1 In the event of cancellation by the client, the deposit is non-refundable. We require a 30 day cancellation notice. Any appointments canceled within 30 days of the wedding, will result in full payment of services.

4/2 If the wedding is rescheduled, every effort will be made to accommodate the new date, subject to availability.

4/3 In the case of serious illness on our teams end, on the day of wedding we will do everything possible to have a back up stylist.

4/4 Cancellations by SALON FIFTY FOUR due to unforeseen circumstances will result in a full refund of the deposit.

4/5 If the bridal party arrives more than 15 minutes late, services may be modified or shortened to accommodate the remaining schedule. However, the full cost of the originally booked services will still apply.

5. CLIENT RESPONSIBILITIES:

5/1 For the day of your services, please arrive with a fresh clean face. For hair, be sure it's washed, fully dry and brushed through.

5/2 We suggest choosing one person ahead of time to assist with your veil.

5/3 Please limit extra guests for your wedding day & trial due to limited salon space.

5/4 Please arrive 10 minutes early before your party start time.

6. CHANGES ON THE DAY OF THE EVENT:

6/1 Last-minute cancelations will still require full payment.

7. SATISFACTION GUARANTEE

7/1 The stylist will make reasonable efforts to achieve the desired look.

7/2 Any concerns or dissatisfaction must be communicated on the day of the event to allow for immediate adjustments.

8. PHOTOS/VIDEOS FOR MARKETING

8/1 The client grants SALON FIFTY FOUR/STYLIST permission to take photographs and/or videos of the completed look for marketing and promotional purposes.

8/2 The client retains the right to request any specific restrictions on the use of these images.

9. CARD PAYMENT

9/1 A credit card is required to book all wedding parties. This information will be kept confidential and will be eliminated after the wedding.

9/2 This card will be used for booking deposit and any unpaid services.
